Program Overview

The Apple Authorized Service Provider (AASP) program is designed for companies interested in offering inwarranty and out-of-warranty repair service for any Apple product. Qualifying companies can gain access to genuine Apple parts, tools, training, service guides, diagnostics and resources to perform these repairs.

Companies, organizations, and universities and colleges in regions where Apple has a direct service presence may apply to become an Apple Authorized Service Provider.

How Apple will use the information provided

Apple will use the information provided to determine whether your organization is a good fit for the Apple Authorized Service Provider Program. This information will be reviewed and followed up by the Field Service program team and if deemed a good fit the team will outreach for further information.

Apple may request from a consumer reporting agency and for employment-related purposes, a "consumer report(s)" (commonly known as "background reports") containing background information about you to determine eligibility for engagement for services (including independent contractor, or volunteer assignments, or program participation, as applicable). The background report will be conducted by a third-party agency of Apple's choosing with the cost of the background report to be covered by the applicant.

Note, Apple may provide a credit line to credit eligible applicants for use with Apple purchases (e.g. required tools, equipment, service parts). The credit application form is used to confirm that the applicant can achieve a minimum Apple required credit limit to perform business. The credit form will be located at the end of this packet and is a requirement for submission. Apple uses Dunn & Bradstreet as a resource for credit information. Once Apple receives a completed packet with all requirements you will receive a reply referencing your request number. Please include this number in all correspondence during the evaluation period. Apple reserves the right to make any determination on eligibility and whether an organization is accepted as an Apple Authorized Service Provider Program.

 - Shop front / street frontage
 - Exterior of customer entrance
 - Area of the shop that is visible to customers

 - Photos of ESD compliance area
 - Safety equipment (including fire safety equipment)
